#### **1. Learning**


This component is made by conferences, capacitating, learning circles with the learning partners, which includes activities for the sensitiveness strengthen about the problematic.

#### **2. Social**


Is the effort made in order to strengthen the job of the involved organizations through the international and enterprising volunteers, who are using their knowledge for generate an impact in the affected population.

**Internacional Trainees and Enterpriceing University students:**

They will support the strengthen the work of 5 social organizations in many ways:

- **Management:** Accounting, informatics and manage tasks.
- **Comunication and sensitization:** Inform about the performance of the NGO´s and of the projects which are developed, and support the running of the task of communication and sensitization.
- **Project´s formulation:** Formulate social projects for the organizations who could find financial resourses for the execution phase.

**Impacts of project:**

- Strengthen of the 5 social foundations, which are recognized due to their labor with children in the country.
- **Leadership education focused in social enterpreunoral activities.;** 24 participants of the project, colombian and foreigners leaders, will be enabled in the field of social enterprising in order to transfer the information in the whole membership of the Project.
- Creation of social awareness around the children´s problematic, involving other social entities.
- Propitiate different types of spaces for the deep-thinking and learning about the importance of improve the social, cultural and economical context of many Colombian children.
- Enable the participants to understand more the field of social enterprising, focused on the children problematic, in order to be able to assume leadership and active roles
- Through this Project, more than 6000 persons will be impacted.
